## Forging Capabilities:

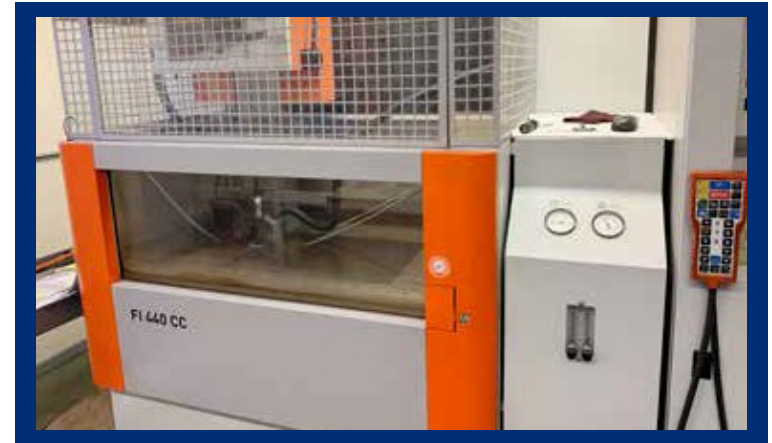
- (1) 1500 ton Mechanical Forge
  - 28" stroke 60"x40" part size capability, 20 cycles per minute continuous
- (2) 800 ton Mechanical Forges
  - 1 PLC (auto) controlled 20" stroke, 20 cycles per minute
  - 1 manual controlled 10" stroke, 10 cycles per minute
- Forging Furnaces with temperature capability up to 2500°F

## Machinery Capabilities:

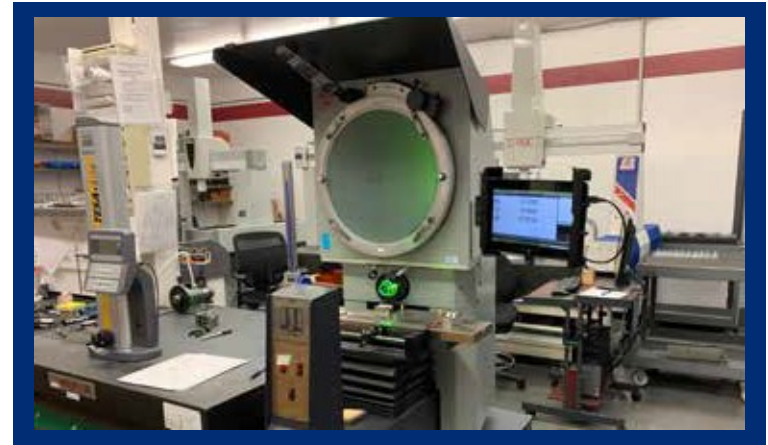
